

WHITE LODGE NURSERY COVID-19 POLICY

This policy outlines practical measures to reduce the risk of Covid-19 spreading at White Lodge. It details the steps we are taking to protect our children, young people and staff, whilst enabling us to provide essential care to our vulnerable client group.

We are all required to be mindful that our procedures are well thought out and balanced to ensure that we do not significantly increase children or young people's anxieties, which will inevitably have a detrimental effect on their mental health and well-being.

Background

- Young people are likely to become infected with coronavirus (COVID-19) at roughly the same rate as adults, but the infection is usually mild.
- The most common symptoms of coronavirus (COVID-19) are a new, continuous cough, a high temperature (over 37.8 degrees) and a loss of; or change in, your normal sense of taste or smell (anosmia).
- For the vast majority of children, young people and staff, coronavirus (COVID-19) will not cause serious illness. (Coronavirus (COVID-19): implementing social distancing in education and childcare settings, 24.3.2020)
- On the 11th May government issued guidance for the return of all children into early years settings from the w/c 1st June at the earliest. This depends on the most up-to-date assessment of the risk posed by the virus.

Keeping up to date with government guidance

- The Senior Staff of White Lodge will review government guidance regularly in particular for; <u>vulnerable</u> <u>young people</u>, <u>guidance on isolation for residential educational settings, Residential care and Actions for early years and childcare providers during the coronavirus outbreak.</u>
- A minimum of weekly contact with Surrey County Council to review our policy and procedures
- The senior staff will update this policy immediately when new guidance is released and distribute to all staff on site without delay, who will sign to say they have read and understood it
- Senior Staff will ensure they review the latest guidance, staffing levels, supplies and risk

How we can minimise the risks of transmission

- We will take active steps to make sure anyone who is feeling ill stays at home by;
 - Phoning parents the day before to ensure their child and members of the family are well and not showing signs and symptoms of COVID-19
 - We will advise parents that the child's temperature will be taken before entering White Lodge Nursery.





- o Informing parents/carers that if their child becomes ill, they must be able to pick them up promptly or have someone on standby to do so
- Review our visitors policy
 - No visitors, other than those deemed as required such as contractors for essential work, will be permitted inside White Lodge
 - Our Reg 44, Independent visitor will be asked if they can carry out their necessary inspection by phone contact/Skype with staff, parents/carers and young people
 - Parents to be advised that they should wait in their cars or at a distance of 2 metres away from each other when collecting their young people and dropping off
 - o Nursery has staggered drop off / pick up times for children attending.
 - Nursery parents are advised to drop off / pick up at the garden gate next to the Treetops building.

Regular hygiene

- Carers and Nursery staff will supervise children to ensure they wash their hands for 20 seconds more often than usual, in particular before meals, on entering and exiting the building and before and after any personal care needs with soap and water or hand sanitiser and catch coughs and sneezes in tissues. Nursery staff will support children who are unable to do that themselves by using clean cloths, soap and water.
- Posters will be displayed around White Lodge on correct handwashing techniques and carers will
 actively teach young people the elements of good general hand hygiene

Activities

- o All activities will be at White Lodge either inside or in their grounds
- There will be no activities off site

Social distancing

- Where reasonably practical, staff should keep a 2 metre distance, however this cannot be of the
 detriment to the care of the children and young people. Nursery children are kept a 2 metre from
 each other where practical. We will utilise all 3 buildings at White Lodge to facilitate activities that
 encourage social distancing.
- Increased cleaning activity
 - Cleaning will follow every activity ensuring all hard surfaces, door handles, toilets, key pads and bathing facilities will be cleaned.

Wearing personal protective equipment

If neither the care worker nor the individual receiving care and support is symptomatic, then no personal protective equipment is required above and beyond our normal good hygiene practices except for masks when caring out personal hygiene.

New PPE must be used for each episode of care. It is essential that used PPE is stored securely within disposable yellow rubbish bags. These bags should be placed into another bag, tied securely and placed outside in the clinical waste bin.

If a child or young person has symptoms of COVID-19 whilst at White Lodge





If a child or young person is showing signs of having COVID-19, staff should contact the parent/carer immediately and ask them to collect their child.

We are not expected to have dedicated isolation facilities at White Lodge, but should implement isolation precautions when someone at White Lodge displays symptoms of COVID-19 in the same way that they would operate if an individual had influenza.

Whilst they are waiting for the parent/carer, the child or young person should be isolated in a separate room.

Laundry

Do not shake dirty laundry before washing. This minimises the possibility of dispersing virus through the air. Wash items as appropriate in accordance with the manufacturer's instructions.

If a member of staff is concerned they have COVID-19
